## **Auto Plus Fall 2022 Rewards Contest Rules**

These rules, along with the information provided on the Auto Plus Fall 2022 Rewards Contest promotional materials (the "Contest Materials") (collectively "Contest Rules") are the complete, official rules for the Auto Plus Fall 2022 Rewards Contest. The Contest is sponsored by Auto Plus Auto Parts, located at 112 Townpark Dr Suite 300, Kennesaw GA 30144 ("Auto Plus" or "Sponsor"). Auto Plus reserves the right to disqualify any Participant who is found to breach these Contest Rules.

**CONTEST PERIOD:** Beginning on August 1, 2022 ("Registration Open Date") and ending September 15, 2022 ("Registration End Date"), the Contest will be open for Participants to register to participate. The Contest will be open to receive registrations at 12:00:01 A.M. ET on the Registration Open Date and close to registrations on the Registration End Date at 11:59:59 P.M. ET (the "Registration Period"). Participants must register during the Registration Period to participate in the Contest. Any registrations received after the Registration Period will not be considered valid registrations. Participants shall register by filling out the Fall 2022 Rewards Program form and submitting it to your Commercial Account Manager before the Registration End Date.

It is the Participant's (defined below) responsibility to check the Contest Rules regularly throughout the Contest to stay informed of any new or updated deadlines. Auto Plus is not responsible for any Participant's failure to do so.

Note: Sponsor's computer is the official timekeeping device for this Contest.

**ELIGIBILITY**: The Contest is open only to Auto Plus Parts VIP Customers only, that are registered corporate entities in the United States and the District of Columbia, excluding Arizona ("Participants"). The following entities are not eligible to participate: (i) employees of Auto Plus, and any of their affiliate companies or subsidiaries; (ii) family members (spouse, parents, siblings and children) of any individual referred to in clause (i), and (iii) persons living in the same household (whether or not related) with any person referred to in clause (i) or (ii) above. This Contest is subject to all federal, state, and local laws and regulations and is void outside the United States and where prohibited by law.

Sponsor reserves the right, in its sole and absolute discretion, to refuse to accept any registration for any reason.

**SELECTION OF POTENTIAL WINNERS:** The Contest is a challenge of skill and the final results will be determined as provided below.

Winners will be selected to receive the prizes provided below based on the dollar amount of sales made in Qualifying Purchases between August 1, 2022 at 12:00:01 A.M. ET and September 15, 2022 at 11:59:59 P.M. ET (the "Promotion Period") excluding applicable sales taxes ("Gross Sales").

"Qualifying Purchases" shall mean new, bona fide, non-returned purchases made at regular prices from an Auto Plus Store on your commercial account during the Promotion Period in the following lines: Wagner, Moog, Monroe, and Quick Steer. Any purchases that have been returned will not be considered Qualifying Purchases.

"Growth" shall mean the difference between Gross Sales made during the Promotion Period and Gross Sales made between August 1, 2021 and November 30, 2021.

Winners will be selected within 60 days of the end of the Promotion Period.

Unless otherwise provided below, winners shall be selected based on the Region of their primary business location as provided on the registration. The Regions are defined as follows: Region 1 is customers in DE, FL,GA, MD, MO, MS, NC, Southern NJ, OK, Southern PA, TN, TX, VA and Region 2 is customers in CT, IA, IN, MA, NH, NY, Northern NJ, OH, Northern PA, RI, WI and WV. Please contact your Commercial Account Manager for more information on what region your account is serviced through.

# PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):

#### **Grand Prizes:**

Two (2) Grand Prize Gross Sales winners shall be selected in each Region (for a total of four (4) Grand Prize Gross Sales winners) to receive a \$10,000 bill credit against tools and equipment purchased from Integrated Supply Network ("ISN") based on the highest Gross Sales during the Promotion Period. Winners must set up an account with ISN before their bill credit as a "Grand Prize Gross Sales" winner can be redeemed. Bill credits may only be applied to purchases of inventory that are in stock at the time of purchase.

Two (2) Grand Prize Growth winners shall be selected in each Region (for a total of four (4) Grand Prize Growth Winners) to receive a \$10,000 bill credit against tools and equipment purchased from ISN based on the highest Growth (as defined above). All prizes in the form of bill credits must be used within 12 months of the credits being applied to a winner's ISN account.

### **Product Prizes:**

Two hundred (200) Wagner winners shall be selected based on highest Gross Sales of Wagner Brake and Lighting products made during the Promotion Period to receive a Milwaukee® M12 3/8" Cordless Impact Wrench (MLW2554-22), APR \$254.05.

Two hundred (200) winners shall be selected based on highest Gross Sales of Moog/Quick Steer products made during the Promotion Period to receive a Milwaukee® M12 FUEL Cordless Right Angle Die Grinder (MLW2485-22), APR \$249.15.

Two hundred (200) Moog winners shall be selected based on highest Gross Sales of Monroe/Rancho Ride Control products made during the Promotion Period to receive a Milwaukee® M12 FUEL 3/8" Cordless Hi-Speed Ratchet Kit (MLW2567-22), APR \$244.89.

Product Prizes are selected from all Participants and are not awarded based on Region.

If a Participant earns both a Gross Prize and Growth Prize, they will be awarded only the Gross Prize and will be ineligible to receive a Growth Prize. #### Ties:

In the event of a tie for the Gross Sales Prizes, winners will be selected based on which Participant achieved the highest Growth.

In the event of a tie for all other prizes, Winners will be determined based on which Participant achieved the overall highest Gross Sales of all Qualifying Products during the Promotion Period.

## **Eligibility:**

Prize awards are subject to verification of eligibility and compliance with these Contest Rules. All decisions of the Sponsor will be final and binding on all matters relating to this Contest.

Winners will be selected sixty (60) days after the close of the Promotion Period and will be notified by email to their email address on their Auto Plus account.

Sponsor cannot accurately predict the number of Participants who will participate in the Competition and odds of winning depend upon the number of Participants and the skill level of the Participants.

**WINNERS' OBLIGATIONS (DELIVERY & DOCUMENTATION):** If a prize is valued at \$600 or more and the winner is subject to US tax obligations, the potential winner must also sign and return an IRS W-9 form, within the stated time in order to claim the prize.
